- 2016 Taconite Production Tax in the amount of \$71,888 was deposited into the General Fund. Transfer \$55,353 from General as follows per Levy percentages: \$40,257 to Road & Bridge; \$5,751 to Road Enhancement; \$4,313 to Building; \$4,313 to Fire; \$719 to Cemetery. Transfer a total of \$33,575 from the Funds to the Capital Improvements Fund as shown.
